Sound can be deceiving. Over time your hearing “comfort level” adapts to higher volumes of sound. What sounds “normal” can actually be loud and harmful to your hearing. Guard against this by choosing a safe level BEFORE your hearing adapts.

### TO ESTABLISH A SAFE LEVEL:

- Start your volume control at a low setting.
- Slowly increase the sound until you can hear it comfortably, clearly and without distortion.

### ONCE YOU HAVE ESTABLISHED A COMFORTABLE SOUND LEVEL:

- Do not exceed that level.



Taking a moment to do this now will help to prevent hearing damage or loss in the future. After all, we want you listening for a lifetime.

## harman kardon 5-Year Limited Warranty -Loudspeakers

**U.S. Warranty – For warranty information outside the U.S., please contact your local distributor. Warranty service is only available in the country of original purchase. This is an important document. Attach your bill of sale to this card and keep it in a safe place. Your bill of sale is your warranty.**

The harman kardon warranty on loudspeakers (except enclosures) remains in effect for **five years** from the date of the first consumer purchase. Enclosures are warranted for **two years** from the date of purchase.

### WHO IS PROTECTED BY THIS WARRANTY

The harman kardon warranty protects the original owner and all subsequent owners, provided that the harman kardon product was purchased within the continental United States, Alaska or Hawaii from an authorized dealer who was authorized by the harman kardon manufacturer to sell such products at the time of the original purchase, or purchased by military personnel from an authorized military outlet. **A copy of the original dated bill of sale must be presented whenever warranty service is required.**

### WHAT IS COVERED BY THIS WARRANTY

Except as specified below, the harman kardon warranty covers all defects in material and workmanship. The following are not covered: damage caused by accident, misuse, abuse, product modification or neglect; damage occurring during shipment; damage from failure to follow instructions contained in the instruction manual; damage resulting from the performance of repairs by someone not authorized by the harman kardon manufacturer; damage caused by installation of parts that do not conform to harman kardon specifications; units used for other than home use; units not used for their intended purpose; any claims based on misrepresentations by the seller; products sold on an "as is" or final-sale basis; or the cost of installing, removing or reinstalling the unit. The harman kardon liability is limited to the repair or replacement, at our option, of any defective product and shall not include incidental or consequential damages. The harman kardon manufacturer reserves the right to replace ad is continued model with a comparable model. Any replacement units or parts may be new or rebuilt.

**NOTE:** Repair of our product must be done by an authorized dealer or service center. **Unauthorized repair will void the warranty and is done at the risk of the consumer.**

You are responsible for transporting your product for repair or replacement. The harman kardon manufacturer will pay reasonable return charges for delivery to any location in the continental United States, Alaska or Hawaii if the repair or replacement is covered under the warranty. Please save the original shipping carton(s), as a charge will be made for additional cartons.
